This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

### **Section 4 - First Aid Measures**

### **General Information:**

# **Section 5 - Fire Fighting Measures**

### **Section 6 - Accidental Release Measures**

Accidental release: Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. Eye/face protective equipment should comprise as a minimum, protective glasses and, preferably, goggles. # Section 10 - Stability and Reactivity
